ALAYNE ADAMS is an Assistant Professor at Columbia University School of Public Health, in the Centre for Population and Family Health. She received her doctorate in 1992 from the London School of Hygiene and Tropical Medicine; it focused on seasonal food insecurity and nutritional, social and economic risk among agriculturalists in central Mali. She has done further fieldwork in Mali and in Bangladesh.

JOCELYN ALEXANDER is a Senior Associate Member of St Antony's College, Oxford. She is completing a book on the history of Matabeleland North (Zimbabwe) with Professor Terence Ranger and Dr JoAnn McGregor. She has also done research in Mozambique; in 1997 some of her findings were published in *Africa* (67.1).

JINDRA CEKAN works in Baltimore as Food Security Adviser for Catholic Relief Services; she oversees the food security programming for over ten countries in Africa. In 1994 she got her doctorate (in international political economy) with a thesis on the famine early-warning system in Mali, the *système d'alerte précoce*.
