**Rick Bonnie** is a Ph.D. candidate in the Department of Archaeology, Art History and Musicology at the Katholieke Universiteit Leuven, and holds a Ph.D. fellowship of the Research Foundation – Flanders (FWO). He received an MA in archaeology (*cum laude*) from Leiden University (2008). His main research interests lie in Roman archaeology, with a special focus on the Roman east (though not exclusively), in the way material assemblages can be put to use in analysing cultural identity, and in cultural resource management. He is currently working on a Ph.D. project concerning the archaeology of the Roman period in Galilee (northern Israel), in which he concentrates on sociocultural changes appearing in the archaeological record during the second century A.D.

**Geoff Carver** has excavated for state services, university departments and private companies in Canada, England, France, Denmark, the Netherlands, Germany, Israel and the USA. The proceedings of a series of sessions on field methods that he organized for EAA and UISPP conferences were published by BAR under the title *Digging in the dirt* (2004). He has also published papers on archaeological information systems (AIS), soil colour, the epistemological basis of archaeological documentation (especially the interplay between documentation media and stratigraphic theory), modelling post-depositional transformations to the archaeological assemblage, the problems in applying reflexive methods in certain on-site divisions of labour, and so on. After studying for a Ph.D. in archaeology and GIS, he has been working mostly as a CAD technician.

**John F. Cherry** is the Joukowsky Family Professor of Archaeology in the Joukowsky Institute for Archaeology and the Ancient World, Professor of Classics, and Professor of Anthropology, at Brown University. He holds a BA degree in Classics (Bristol 1968), an MA degree in anthropology (University of Texas 1973), a Ph.D. in archaeology (Southampton 1981), and honorary MA degrees from the University of Cambridge and Brown University. He has led several archaeological survey projects in Greece, and has also done fieldwork in the United Kingdom, in the United States, in Italy, in southern Armenia and, currently, on the island of Montserrat in the Caribbean. He has co-authored or co-edited twelve books, including most recently *Explaining social change. Studies in honour of Colin Renfrew* (2004) and *Prehistorians round the pond. Reflections on Aegean prehistory as a discipline* (2005). A former co-editor of *World archaeology*, he has been co-editor of the *Journal of Mediterranean archaeology* for the past two decades.

**Jean-Paul Demoule** is Professor of Later European Prehistory at Paris 1 University (Panthéon-Sorbonne). He directed excavations in the Aisne valley, as well as in Greece and Bulgaria. Particularly interested in issues related to rescue archaeology, he participated in drawing up French legislation on

rescue archaeology, as well as in the establishment of the Institut national de recherches archéologiques préventives (Inrap), over which he presided from 2001 to 2008. His research has focused on the neolithization of Europe, Iron Age society, the history of archaeology and its social role, and the construction of ideologies. His main publications as author, editor or co-editor include *Guide des méthodes de l'archéologie* (3rd edn 2009), *La France archéologique, vingt ans d'aménagements et de découvertes* (2004), *L'archéologie préventive dans le monde* (2007), *Naissance de la figure, l'art du paléolithique à l'âge du fer* (2007), *The origin and evolution of languages. Approaches, models, paradigms* (2008), *L'Europe, un continent redécouvert par l'archéologie* (2009), *La fabrique de l'archéologie* (2009), *La révolution néolithique dans le monde* (2010).

**Matt Edgeworth** is Research Associate and Project Officer at the University of Leicester, UK. He obtained a BA and Ph.D. in archaeology and anthropology from the University of Durham. He wrote an ethnography of excavation entitled *Acts of discovery* (Archaeopress 2003), and edited the book *Ethnographies of archaeological practice* (Altamira 2006). He is currently writing a book on the archaeology of water flow for the Duckworths Debates in Archaeology series, due to be published in late 2011.

**Fleur Kemmers** is Lichtenbergprofessor of Coins and Money in the Graeco-Roman World at the Goethe University, Frankfurt am Main. Her research is characterized by a strong interdisciplinary character, and combines theories, methods and data from the fields of archaeology, ancient history and numismatics. Current research interests include the development of coinage in the Mediterranean world, the use of coins as a means of communication and the academic position of numismatics. Together with Nanouschka Myrberg she organized a session on Coins and Contexts at the XIV International Numismatic Congress in Glasgow 2009.

**Jan C.A. Kolen** is Professor for the Heritage and History of the European Cultural Landscapes at VU University Amsterdam, where he teaches archaeology, landscape history and heritage studies. He is also the Director of the CLUE research institute (VU University Amsterdam), which studies the history, heritage and transformation of the cultural landscape and urban environment from a European perspective, combining insights from archaeology, history, geography and economics. He was trained as an archaeologist at the University of Leiden and received his Ph.D. at VU University Amsterdam for a thesis on biographical approaches in landscape research. His interests include the archaeology of human evolution, the theory and methodology of archaeology, cultural heritage, landscape history (including landscape archaeology) and environmental planning.

**Nanouschka Myrberg** is a Ph.D., researcher and lecturer at the Department of Archaeology and Classical Studies in Stockholm University, Sweden. A historical archaeologist specializing in numismatics, her research interests include the theoretical and methodological integration of the dimensions

of object, text and picture; the construction of epistemology and academic discourse; and the construction of identity, ethnicity and authenticity. Current research treats coins as cultural biographies, the relation between humans and objects and the ‘archaeology of the senses’. Together with Fleur Kemmers she organized a session on Coins and Contexts at the XIV International Numismatic Congress in Glasgow 2009.

**Ndukuyakhe Ndlovu** was born at Osizweni in Newcastle, South Africa. He has studied at the Universities of the Witwatersrand and Rhodes, where he obtained a BA degree (1999), a BA honours degree (2000), a Postgraduate Diploma in science (2001) and an MA in anthropology (2005). He is currently a third-year Ph.D. candidate in the International Centre for Cultural and Heritage Studies (ICCHS) at Newcastle University, UK, and general editor of *e-pisteme*, a postgraduate and early career researcher’s journal at Newcastle University. He has about nine years’ experience in heritage management in South Africa, having worked for both national and provincial heritage authorities in various capacities. At the moment his research interest regards the distribution of rock art in Southern Africa. In addition, he is also working to transform the archaeological discipline in South Africa to include more African archaeologists to make it easier to challenge dominant ideologies, and to support more public archaeology.

**Björn Nilsson** is Senior Lecturer in the Department of Archaeology at Södertörn University, Sweden. After receiving a Ph.D. from Lund University in 2003 he worked for five years in rescue archaeology as assistant head of the Archaeology Department, Malmö Kulturmiljö. He is currently involved in a research project which primarily focuses on field archaeological knowledge production and actor-network theory.

**Rachel Pope** is a prehistorian at the School of Archaeology, Classics and Egyptology of the University of Liverpool, focusing on British Bronze and Iron Age material through to A.D. 400, with research interests too in the continental European Iron Age. Her research currently specializes in roundhouse architecture, everyday life and domestic ritual, as well as settlement temporality and land use. Her writing considers the history and development of archaeological theory and method beyond analogy, as well as gender politics – both historically and in contemporary archaeology, with her work for *British women archaeologists*. Rachel has excavation experience on more than 20 British prehistoric sites. She is co-director of the Kidlandlee Dean Landscape Project in Northumberland, whilst also working on the Habitats and Hillforts project in Cheshire and Heather and Hillforts in North Wales. Recent publications include an Oxbow monograph on *The earlier Iron Age in Britain and the Near Continent*, with another in preparation entitled *Prehistoric dwelling*. Beyond archaeology, she also co-parents her young daughter.

**Silvia Tomášková** a native of Czechoslovakia and a Canadian citizen, received her Ph.D. at the University of California at Berkeley in 1995. She is an

Associate Professor of Women's Studies and Anthropology, and Director of the Women and Science Program at the University of North Carolina at Chapel Hill. Her research interests are the Old World Palaeolithic, history and theory in archaeology, and studies of science. She recently completed a book about shamans, the history of their 'discovery' in the process of Russian colonialism in Siberia, and their transformation in scientific archaeology of the 20th century. This year she started a new field project on rock art in South Africa.

**Ezra B.W. Zubrow** is Professor of Anthropology at the Universities of Buffalo and Toronto. He is a senior research scientist at the National Center for Geographic Information Analysis, as well as presently Yip Fellow, Magdalene College, University of Cambridge. He has surveyed and excavated in North and Central America, the Middle East, Western Europe and Asia. Presently, he directs NSF's International Circumpolar Excavation Project (ICAP), which is surveying and excavating in northern Canada (Factory Lake), northern Finland (Yli-ii), and northern Russian Siberia (Kultuk point, Kamchatka).

## Guidelines for contributors

*Archaeological dialogues* is a broad, peer-reviewed journal for debating archaeology. Articles should be accessible to an audience which may be unfamiliar with the specific period and region discussed. Transparent writing is encouraged above abstruse reasoning. Jargon should be avoided and succinct writing is appreciated. We value good illustrations. These can include photographs, line-drawings and maps.

### Procedure

The *Archaeological dialogues* publishing process includes the following steps: submission, evaluation, decision (acceptance, modification or rejection), copy-editing, proof-reading, publication, and distribution. In order to guarantee efficient and quality publication contributors are requested to adhere closely to the following guidelines:

- All manuscripts should be written in English. Manuscripts that seriously fail to conform to the guidelines will be returned to authors for revision before they will be considered.
- When submitting a contribution to *Archaeological dialogues*, it will be acknowledged on receipt. One of the editors will be the contact person for a paper throughout the entire process. If scope, quality and language are appropriate it will be sent to two anonymous referees for expert opinion. Usually within two or three months, the editors will inform you of their final decision. In the case of rejection, an editorial justification will be provided, including the original referees' reports. In the case of acceptance – which may be conditional on revisions – one of the editors will guide you through the rest of the publishing process. Before an article goes into print, authors will receive a copy of the proofs to check. The entire procedure between submission and appearance should take less than a year.

### Types of contributions

*Archaeological dialogues* essentially publishes two types of papers, namely 'discussion articles' and 'notes'. The former are accompanied by published comments and a reply. Discussion articles are usually longer, they can be up to 8–9000 words whereas notes typically are around 4–5000 words. Discussion articles usually take longer to appear in print because of the time required for comments and reply. Review essays and interviews are usually solicited by the editorial board, but scholars with suggestions in this direction are encouraged to contact us.

### Submission of contributions

Manuscripts are preferably received by email ([ad@arts.gla.ac.uk](mailto:ad@arts.gla.ac.uk)). Alternatively, a CD and hardcopy may be sent to: Archaeological Dialogues, VU University, Faculty of Arts, De Boelelaan 1105, 1081 HV Amsterdam, The Netherlands.

Authors are solely responsible not only for the contents of their manuscripts, but also for securing any legal rights or permissions to publish submitted material, including copyright-protected materials. The appropriate acknowledgements should be given in captions, endnotes, or elsewhere. Manuscripts should not be submitted to (nor should they have been published in) any other journal or publication.
