Papers should be double-spaced: font in 12 point Times New Roman. Articles not longer than 12,000 words are desirable. Longer pieces may be allowed at the editor's discretion. All self-identifying marks should be removed from the article itself to facilitate blind reviews. Submitting an article to *Episteme* implies that it has not been published elsewhere and is not being considered for publication elsewhere. Authors must obtain written permission to publish any material of which they do not own the copyright.
