Instruction will emphasise particularly the application of these techniques to data collections held by the School. Full supporting interactive computer facilities will be available. Special evening seminars and a weekend colloquium with visiting speakers will be held. Special provision will be made for French-speaking participants. This year there will again be a concurrent summer school in quantitative methods for historians. There will be ample opportunities for mixing between the two schools, and for exchange of ideas and criticisms. Financial support may be available to participants from their own Institutions or National Research Councils; failing such support, the Consortium may offer aid to suitable applicants.
