#### THE EDINBURGH MATHEMATICAL SOCIETY

The Edinburgh Mathematical Society was instituted in 1883 for "the promotion and extension of Mathematical Science, Pure and Applied".

Nominations for Ordinary Membership are received at any one Ordinary Meeting and voted upon at the next. Members receive notices of all meetings and may subscribe to the Proceedings at a reduced rate. Further information about membership can be obtained from the Secretary.

The Society's Proceedings, containing papers embodying the results of research that is original in matter or manner, are published in parts. Three parts complete a volume. One volume is issued each year. Series I comprised forty-four volumes published from 1884 to 1926. Series II commenced in 1927.

Papers to be considered for publication should be sent to the Secretary. Manuscripts (2 copies) should be typewritten on A4 paper with double spacing and generous margins. The style and arrangement should conform to current practice in the Proceedings. Each manuscript should contain a short abstract of not more than 200 words and also a primary classification number from the American Mathematical Society's 1980 Mathematics Subject Classification Scheme. References, including titles of papers, should be given in the form adopted by Mathematical Reviews, footnotes being avoided if possible. Figures should be separated from the text and lettered, ready for photographic reduction; their intended location should be clearly indicated. Manuscripts which are not suitable for submission to the printer will not be accepted. Authors are advised to retain a copy of any material submitted, as the Society cannot accept responsibility for any loss.

A proof is supplied once. Authors are particularly requested to correct and return the proof promptly. Excessive corrections may be charged to authors. Fifty free offprints, and additional copies at cost, will be supplied if ordered on a form returned with the proof.

The Proceedings are published at the price of £50.00 (\$120) for a volume of three parts.

# NEW FROM SCOTTISH ACADEMIC PRESS

## JAMES STIRLING 'This about series and such things'

by

### lan Tweddle

This book is concerned with certain aspects of the work of the Scottish mathematician James Stirling (1692-1770). Although Stirling enjoyed a substantial reputation among his contemporaries in Britain and other European countries, he published remarkably little. His major contribution to mathematics was a book published in 1730 which was a treatise on infinite series, summation, interpolation and quadrature. Thereafter his only research publication was a paper which appeared in *Philosophical Transactions* in 1735. However, it is clear from his correspondence and unpublished notes that Stirling remained active in research well into the 1740s.

It is this later work along with related parts of the aforementioned publications which forms the subject matter of this book. Much of the material has been extracted from his unpublished notebooks and these extracts probably belong to the period 1730-1750. To help put the period under consideration into perspective the author has included a short account of Stirling's career in the Introduction.

**Dr lan Tweddle** gained a BSc and PhD in mathematics from the University of Glasgow. Since then he has held several lecturing posts in Mathematics in Canada, Australia and Scotland. The author of numerous mathematical papers, Dr Tweddle is presently Lecturer in Mathematics at the University of Strathclyde and Honorary Lecturer at the University of Stirling.
