Corporate governance has become an important issue in all industrial economies. This book has grown out of a conference entitled *Comparative Corporate Governance: An International Conference, United States-Japan-Western Europe* which was held in Brussels on 14 June 1995. It was organized by the Finance Law Institute of the University of Ghent and the Study Center on Groups of Enterprises in Brussels under the scientific direction of Eddy Wymeersch. The book contains the speakers' contributions in an enlarged and updated form together with a selection of 18 documents on corporate governance from seven countries (United Kingdom, U.S.A., Canada, France, Germany, The Netherlands, and Belgium). These documents offer a wealth of data, insights, self-regulatory experiences and legislative proposals which show that, despite all the deep-rooted national differences, the core problems are very similar.


