## Evaluation of Processes and Indicators in Infection Control (EPIC) Study

This summer, SHEA's Project to Monitor Indicators (PMI) Committee will start a new study that addresses clinical indicators related to primary bloodstream infection (BSI) associated with central venous catheters. The indicator portion of the study will evaluate the effect of various performance-measurement systems on a hospital's BSI rate. The process portion of the study will assess patient, device, practitioner, and organizational characteristics

## Accreditation Council for Continuing Medical Education Approves SHEA

SHEA recently received notification from ACCME that it is now fully accredited as a sponsor of CME programs. This decision was based on a recent site visit conducted by ACCME. It was determined that the mission statement, needs assessment, objectives, educational design, evaluation, and management of our CME offerings during the 2 years that SHEA was provisionally accredited were all in substantial compliance with ACCME requirements.

As a result of this, not only SHEA's own presentations, such as our annual meeting and our training courses, can continue to offer physicians CME credit but we also can do so for organizations that are able to follow the ACCME guidelines but have not gone through the rigorous process of ACCME accreditation that SHEA underwent under the leadership of Robert Weinstein, MD, who continues as chair of the SHEA CME Committee.
