

Aims and scope

Byzantine and Modern Greek Studies (BMGS) is an internationally recognized, peer-reviewed journal and one of the leading publications in its field. Published twice a year in spring and autumn, its remit is to facilitate the publication of high-quality research and discussion in all aspects of Byzantine and Modern Greek scholarship, whether historical, literary, art-historical, archaeological or social-anthropological. The journal welcomes research, criticism, contributions on theory and method in the form of articles, critical studies and short notes.

Subscription rates *Byzantine and Modern Greek Studies* (ISSN 0307-0131) is published twice a year in April and October. Two parts form a volume. The subscription price (excluding VAT) of volume 41 (2017), which includes print and online access, is £242 (US\$421 in the USA, Canada and Mexico) for institutions. The electronic-only price available to institutional subscribers is £217 (US\$397 in the USA, Canada and Mexico).

The subscription price for individuals ordering direct from the publisher and certifying that the journal is for their personal use is £71 (US\$135 in the USA, Canada and Mexico), plus a reduced electronic-only price of £58 (US\$109 in the USA, Canada and Mexico, AU\$25 in Australasia).
