A PROFILE OF THE CENTER FOR LAW AND HEALTH SCIENCES

The Center for Law and Health Sciences, located on the sixteenth floor of the Law Tower, is the health law research arm of the Boston University School of Law and is committed to an interdisciplinary approach to the study of diverse health law problems. Center activity encompasses research, publications, conferences, public advocacy, teaching, and coordination of dual degree programs.

Center attorneys conduct health law research projects in a number of areas, including rights of disabled people, special education issues, and child abuse and its legal implications.

In addition, the Center has recently established a Program on Law and Technology which has undertaken a study of the management of consumer, workplace, and environmental risks to human health. This program is currently conducting research in such complex and interdisciplinary areas as "alternatives to federal regulation for health risk management," "legal and ethical issues of biological monitoring," and "corporate sector strategies for managing health risk."

Funding for these and other Center projects has been provided by the National Science Foundation, the National Endowment for the Humanities, the United States Department of Education, the Massachusetts Developmental Disabilities Counsel, and the Ottinger Foundation.

The Center who coordinates two dual degree programs, J.D./M.B.A. in Law and Health Care Management and J.D./M.P.H. in Law and Public Health, with the Boston University schools of Management and Public Health, respectively.

Center attorneys also teach classes at the Law School. Henry A. Beyer, Interim Director of the Center, offers a seminar on Legal Issues of Importance to Handicapped Persons and Michael S. Baram, Director of the Center's Program on Law and Technology, teaches Environmental Law and Law, Technology, and Risk Management.

November 18. "Career Opportunities in Occupational Health and Safety" Presented by Nicholas Ashford, J.D., Ph.D., Associate Director, Massachusetts Institute of Technology Center for Policy Alternatives.

Dr. Ashford, author of *Crisis in the Workplace*, has been chairman of an O.S.H.A. advisory committee and consultant on management of chemical hazards.

January 20. "Birth Defects: Who May Live? Who Must Die?"

Presented by Gunnar Dybwad, Doctor of Laws, Graduate Degree in Social Work, Professor Emeritus of Human Development at Brandeis University and Adjunct Professor of Special Education at Syracuse University.

On April 15, 1982, a Bloomington, Indiana infant with Down's Syndrome died because his parents would not agree to surgery to correct a deformity in the esophagus—a deformity which prevented the child from receiving nourishment. What should be the law's role in such situations?

February 17. "Public Education of Handicapped Children in the Wake of *Rowley*"

Presented by David Trott, J.D., editor of FOCUS on Special Education Legal Practices.

In June, 1982, the U.S. Supreme Court reversed two lower federal courts and ruled that a school district need not provide a sign language interpreter for a deaf elementary school student. Attorney Trott, who has been Deputy Director and Legal Counsel to the Federation for Children with Special Needs and consultant to the U.S. Office of Education, will ask whether the Court properly interpreted Congressional intent and how school districts should apply the Act in light of the *Rowley* decision.

March 31. "Careers in Health Law: Of What Use is a J.D./M.P.H. or J.D./M.B.A.-H.C.M.?

Presented by George Annas, Chief of Boston University School of Public Health's Health Law Section and Associate Professor of Public Health, and R. Hopkins Holmberg, Director of the University's School of Management Health Management Programs. April 21. "Legal & Medical Aspects of Child Abuse"

Presented by Dr. Judianne Densen-Gerber, a psychiatrist and attorney who, in 1967, founded Odyssey House Inc. in New York, a drug-free rehabilitation program for addicts. This was the prototype for programs for addicts and delinquents in five other states and two foreign countries.

Because child abuse contributes significantly to much addiction and delinquency, Dr. Densen-Gerber has been an outspoken advocate of children's right to be protected. In this regard, she was twice-cited by the U.S. Supreme Court in its recent *New York v. Ferber* decision upholding New York's child pornography law.

SUBMISSION OF ARTICLES

The Editors encourage the submission of manuscripts on a wide range of medicolegal topics for publication in the JOURNAL. Acceptable subjects include health law and policy; legal, ethical, social, and economic aspects if medical practice, education, and research; health-related insurance; and other important or interesting subjects involving the relationship of the life sciences to the social sciences and humanities. The JOURNAL is interdisciplinary. Contributions from specialists in a variety of disciplines are welcomed. All materials should be sent to the Editors-in-Chief, AMERICAN JOURNAL OF LAW & MEDICINE, Editorial Offices, 765 Commonwealth Avenue, 16th Floor, Boston, Massachusetts 02215.

GENERAL FORM: Manuscripts should be typewritten on one side of the paper only, with triple spacing and liberal margins. Manuscripts should be submitted in *triplicate*, i.e., an *original* and two carbon or Xerox copies. The title of the paper and the author's name and address should be given on a covering sheet.

ABSTRACT: A short abstract (normally not exceeding 200 words) succinctly summarizing the content of the manuscript should accompany the manuscript on a separate sheet. If the paper is accepted, the abstract will be published along with the manuscript.

REFERENCES: Footnotes to sources should be numbered consecutively, and placed on triple spaced pages at the end of the text. All footnotes should conform to *A Uniform System of Citation* (13th ed.), published and distributed by the Harvard Law Review Association, Gannett House, Cambridge, Massachusetts 02138. Nonlawyers unfamiliar with this system should follow the citation form accepted in their field and the Editors of the JOURNAL will make the appropriate modifications if the paper is published.

ILLUSTRATIONS: Illustrations and tables accompanying manuscripts should be numbered, provided with suitable legends, and marked lightly on the back with the author's name. Authors should indicate on the manuscript the appropriate positions of tables and text figures. Special arrangements must be made with the Editor-in-Chief for color plates, elaborate tables, half-tone illustrations or extra illustrations, drawings, and photographs.

SELECTION AND EDITING TIMETABLE: Receipt of manuscript will be acknowledged within one week of receipt. Authors will be notified of the manuscript's acceptance or rejection within one to three months, and accepted manuscripts will be published within three to eight months of acceptance.

PROOFS AND AUTHOR OFFPRINTS: Because of time pressures, printer's proofs of articles accepted for publication will *not* be made available to authors. Twenty-five offprints of each article, enclosed in JOURNAL covers, will be distributed to the author or divided among the authors if there is more than one. Orders for additional offprints, for which a fee is charged, must be communicated at least one month prior to publication.

RETURN OF MANUSCRIPTS: Upon request of the author and upon receipt of a suitable envelope stamped with adequate postage, the Editor-in-Chief will return to the author the original of any manuscript not accepted for publication.
