Did humanitarianism predate the Red Cross?

1840-1860: there were men, women and institutions sharing the same concerns as those which motivated Henry Dunant and the "Committee of Five":

- care for wounded soldiers
- *permanent relief societies*
- mutual international aid
- neutral status for the wounded and for medical staff
- protection of prisoners of war.

Founded in Geneva in 1863, the International Red Cross and Red Crescent Movement is now active the world over. Its roots, too, are universal. This is what historians and people working in the field set out to demonstrate during a three-day symposium.
