# COHESION AND CONFLICT

Lessons from the Study of Three-Party Interaction

**David Wilkinson** 

This study, a contribution to the field of conflict research, is concerned with the *triad*, or group of three interacting decision makers. The *triad* is studied as the simplest prototype of a multi-person interaction; it is analysed to throw light on more general problems, where the number of decision makers is larger, or where the decision makers are collective entities such as nations. The method of analysis is by means of mathematical models.

Previous work on *triads* from several relevant disciplines, such as Sociology, Behavioural Science, and Politics, is surveyed, integrated, and assessed. This survey includes not only theoretical models, but also the results of experiments with the *triad*.
