Anna Calori is Research Fellow at the Imre Kertesz Kolleg, University of Jena. Her research interests cover labour and social history, economic history and global history. Her work on the global business history of Yugoslav enterprises has appeared in *Nationalities* and *Business History*. Her current research focuses on economic multilateralism in the non-aligned movement from the 1970s to the present day. For her doctoral studies at the University of Exeter, she researched economic reforms and deindustrialisation in the former Yugoslavia. He is Research Fellow of the German Orient Institute in Beirut and Visiting Professor of African History at the University of Bayreuth. Das deutsche Kaiserreich in Europa* (Vandenhoeck und Ruprecht, Kritische Studien, 2014); *Day to Day Communism: State Enterprises in East German Society* (Michigan University Press, 2014); with Kiran Patel, *Nazism Across Borders: The Social Policies of the Third Reich and their Global Appeal* (Oxford University Press, 2018); and with Michel Christian and Ondrej Matejka, *Planning in Cold War Europe: Competition, Cooperation, Circulation (1950s-1970s)* (De Gruyter, 2018).

Adam Mestyan is Assistant Professor of History at the History Department of Duke University. He is currently working on his second monograph, *Modern Arab Kingship*. Recent publications include *Arab Patriotism: The Ideology and Culture of Power in Late Ottoman Egypt* (Princeton University Press, 2017) and *Primordial History, Print Capitalism, and Egyptology in Nineteenth-Century Cairo* (IFAO, 2021). A graduate of Central European University and a Junior Fellow at the Harvard Society of Fellows, he has been the recipient of various research grants and fellowships, most recently at the Institute of Advanced Studies in Paris, 2018–19.

Ljubica Spaskovska is Lecturer in European History at the University of Exeter. She completed a PhD in History at the University of Exeter in 2014. Between 2014 and 2019 she was a post-doctoral research fellow on the Leverhulme-funded project '1989 after 1989: Rethinking the Fall of State Socialism in a Global Perspective' at Exeter, led by Professor James Mark. She is the author of *The Last Yugoslav Generation: The Rethinking of Youth Politics and Cultures in Late Socialism* (Manchester University Press, 2017) and *1989: A Global History of Eastern Europe* (Cambridge University Press, 2019), with Bogdan Iacob, James Mark and Tobias Rupprecht.

Lukasz Stanek is Senior Lecturer (Associate Professor) at the Manchester Architecture Research Group, The University of Manchester. He has authored *Henri Lefebvre on Space: Architecture, Urban Research, and the Production of Theory* (University of Minnesota Press, 2011) and edited the first publication in any language of Lefebvre's book about architecture, *Toward an Architecture of Enjoyment* (University of Minnesota Press, 2014). In his recent research, Stanek has studied socialist internationalism as a framework of global urbanisation and its architecture. On this topic he has edited *Team 10 East: Revisionist Architecture in Real Existing Modernism* (University of Chicago Press, 2014). His book *Architecture in Global Socialism: Eastern Europe, West Africa, and the Middle East in the Cold War*, which focuses on the collaboration between architects, planners and construction companies from socialist countries and post-colonial countries, was published by Princeton University Press in 2020. Before Manchester, Stanek taught at the ETH Zurich and held visiting positions at Harvard University and the University of Michigan.

Alp Yenen is University Lecturer in Modern Turkish History and Culture at Leiden University. Previously, he was a research associate and senior resident at the University of Basel. He holds a PhD from the University of Basel and a MA degree from the University of Munich. He has published several articles and chapters on the aftermath of the First World War in the Middle East and is interested in the international history of contentious politics in the modern Middle East.

Rona Yona is editor of the journal *Israel: Studies in Zionism and the State of Israel*, published by Tel Aviv University. Her main research field is Jewish nationalism, transnationalism and mass politics, with a particular focus on the labour movement and its youth culture in Mandatory

Palestine and Poland. Her work on Polish pioneers was the first comprehensive analysis of Jewish transnational mass politics in the interwar years. Her book explores the rise of Labor Zionism to the leadership of the Zionist movement: *Zionists Without Borders: Polish-Jewish Pioneers and the Rise of the Labor Movement in Palestine, 1923–1936* [in Hebrew] (2021). Yona has published articles in the *Journal of Israeli History, Gal-Ed, Polin* and elsewhere. She currently teaches at Tel Aviv University, New York University in Tel Aviv and Oranim Academic College.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at http://mc.manuscriptcentral.com/conteurohistory.

Articles should normally be about 8,000 words long, not including footnotes. Review articles should not exceed 6,000 words, including footnotes. The journal also considers special issue proposals. Please contact the editors for details.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

Submission of an article will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of an article, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

Contributors must keep closely to the journal's stylistic conventions. The editors will return any contribution which does not follow the conventions for correction.
