Ownership and Publication of *Compositio Mathematica*. The journal was founded in 1934 and has been owned since 1950 by the Foundation Compositio Mathematica. The Board members of this Dutch foundation are all mathematicians; its President is Prof. G. B. M. van der Geer of the University of Amsterdam. Papers are submitted to the journal's Dutch editorial office, currently based in the Korteweg–de Vries Institute at the University of Amsterdam. Since January 2004, the journal has been published on behalf of the Foundation by the London Mathematical Society (LMS). The LMS celebrated its 150th anniversary in 2015; it is the major British learned Society for mathematics and publishes twelve other journals, five of which are in collaboration with other learned societies, and two book series. Cambridge University Press prints and distributes *Compositio Mathematica* under agreement with the London Mathematical Society.
