Ranging chronologically from the Old English epic *Beowulf* to recent work by such poets as Margaret Atwood and Seamus Heaney, *The Oxford Anthology of Poetry in English* presents the key poems in the English poetic tradition, focusing on work by major figures, with selective treatment of significant minor writers. The editors have attempted to select, from the finest poetry written in English, those works which best reflect the period of their composition, demonstrate the development of a genre or mode, illustrate significant aspects of the individual poet's craft, or speak to the 20th-century sensibility. Every effort has been made to print each poem in its entirety, and the few exceptions are self-contained and are introduced by short notes explaining the overall context.

- An introductory chapter on poetics, plus an extensive essay on prosody by Sally Gall, a scholar specializing in poetic theory

It analyzes writers' compositions and provides sample dialogues between tutors and writers, indicating in the most concrete terms how to talk with writers, how to formulate questions that will spur them to make their own corrections, and how to help them write critically and independently. In addition, the handbook points out issues that frequently arise in the writing process, explores typical writing problems and their causes, and summarizes recent research and thinking in the field of composition.





In detailed readings of four novels with dramatized narrators—Thackeray's *Vanity Fair*, Conrad's *Chance*, Robert Penn Warren's *World Enough and Time*, and John Fowles's *French Lieutenant's Woman*—Siegle juxtaposes the representational assumption that narrative is taken from "actuality" against the constitutive insistence that discourse creates fictive worlds in which the reader may feel at home. He makes an eloquent case for the conjunction of traditional criticism with contemporary semiotic, deconstructive, and ideological approaches.




