

THE PROBLEM OF POLITICAL OBLIGATION:

A Critical Analysis of Liberal Theory

by Carole Pateman, Department of Government, University of Sydney.

It is usually taken for granted that, in fiberal democracies, a bond of political 'obligation' exists between the citizens and the state. The substantive, and controversial, argument of this book is that political obligation constitutes an insoluble problem in the liberal democratic state. It is argued that the problem can be solved only within the context of a participatory democratic system. In reaching this conclusion Carole Pateman offers a general critique of liberal theories and an interpretation of all the familiar arguments and theories about political obligation and democratic consent. Current controversies about 'democracy' and political oblig-ation are fully discussed in the light of both philosophical arguments and empirical evidence from research in political science. The book has major themes arising from the various relationships to the state of the working class and the middle class, and of men and women, and also from the nature and character of political obligation. The difference between 'obligation', a voluntary moral commitment of the in-dividual, and 'obedience' is analysed and a distinction is drawn between obligation and consent, consent and social contrast, and between a liberal. vertical conception of political obligation and a democratic, horizontal conception. Students and teachers of political science will find in this text a broad and knowledgeable survey and critique of classical theories (Hobbes, Locke, Rousseau) and more recent developments (Hegel, Rawls) relating to political obligation and democracy, together with evidence from political research. Students and enlightened observers of social and political change will be stimulated by the arguments presented here, and by the author's controversial conclusions.
