International Political Science Association Edinburgh Congress August 15-21, 1976

SUMMARY OF THE CONGRESS PROGRAM

Approximately 350 papers* will be presented at the Edinburgh Congress; these papers belong in roughly equal proportions to either of three categories: main theme (I), Research Committees (II), special sessions (III).

I. The sessions of the main theme have been organized by the Program Committee of the International Political Science Association (J. A. Laponce, chairman, Anthony Birch, Klaus Von Beyme, Karl Deutsch, Candido Mendes, Marcel Merle, Najdan Pasic, Giovanni Sartori and Stein Rokkan) on the theme: *Time, Space and Politics*. This theme is an invitation to political scientists to relate politics to geography and history; it is also an invitation to geographers and historians to participate to the congress.

II. The sessions of the Research Committees have been organized by the Executive of each of the ten permanent Research Committees of the International Association.

III. The special sessions have been organized at the request of members of the Association.
