The International African Institute's series of "Classics in African Anthropology" is primarily drawn from two generations of a single, distinct family of texts which, taken all together, dominated the academic analysis of society in mid-20th century Africa.

They were the product of two programmes of publications and research – the first, in the 1930s when Bronislaw Malinowski at the London School of Economics was invited by the Institute to train its Research Fellows in his "new branch of anthropology" prior to their doing field work; the second in the 1950s, when further money for publications from Carnegie and research funding from Ford enabled a new series of publications and a second field research programme to get under way, this time under the overall direction of Daryll Forde at University College London.

These works published over the last sixty years make a long and varied list. For this series we offer the reader significant yet often neglected texts which modern experts in each particular field have found to have stood the test of time well.

We believe that, now easily accessible again, these books will prove once more to be of real value – not just to the specialist but also to the descendants (and compatriots) of those who first gave the fieldworker the insights and understanding we all now share.' – *Murray Last, from the series preface*

Of the several forces reshaping West African rural societies and economies in the post-colonial period, one of the most pervasive is the rapid growth of urban demand. This book studies a Yoruba community in the supply hinterland of Ibadan over twenty years. It tells the social and agricultural history of its various producers, from the Nigerian civil war, via the oil boom and bust, to structural adjustment.

It argues that principles of occupational organisation inherited from the past are now being applied to the creation of a competitive and responsive regional market that promises to be one of the most important social forms in West Africa's future.


