The *BULLETIN* of the Australian Mathematical Society began publication in 1969. It aims at quick publication of original research in all branches of mathematics. The *GAZETTE* started publication in 1974 and carries news items, mathematical articles of general interest, and articles on tertiary mathematics teaching.
