It is agreed:

- I. Representations and Warranties.
 - a) Author represents and warrants as follows:
 - i. Author's submission to the Article is original, the Article does not infringe upon any copyright or proprietary rights of a third party, and Author has full power to enter into this Agreement. If excerpts (e.g., text, figures, tables, illustrations, or audio/ video files) from copyrighted works are included, a written release will be secured by the Author(s) prior to submission, and credit to the original publication will be properly acknowledged.
 - ii. Article contains no material that is libelous, an invasion of privacy, or otherwise contrary to law, and does not contain any fraudulent, plagiarized or incorrectly attributed material.

- iii. Author has reviewed the final version of the Article, believes it represents valid work, and approves it for publication. Should the editors of the journal to which the Article has been submitted request the data upon which the work is based, Author shall produce it.
 - b) Author's representations and warranties set forth above are for the benefit of SAA and Cambridge University Press (Cambridge), the publisher of the Journals. Author shall defend, indemnify, and hold harmless SAA and Cambridge for any breach of such warranties.

Author's Original (AO), Any version of the article that is considered by the author to be of sufficient quality to be submitted for formal peer review by a second party. The author accepts full responsibility for the article. Content and layout as set out by author.

Submitted Manuscript Under Review (SMUR), Any version of the article that is under formal review managed by Cambridge University Press (or the Society that owns the Journal). Cambridge University Press (or the Society that owns the Journal) recognizes its responsibility to provide objective expert review and feedback to the author, and, ultimately, to pass judgment on the fitness of the article for publication with an "accept" or "reject" decision. Content and layout follow Cambridge University Press's submission requirements.

Accepted Manuscript (AM), The version of the article that has been accepted for publication in the Journal. Cambridge University Press takes permanent responsibility for the article. Content and layout follow Cambridge University Press's submission requirements.
