

# ***Wearable Technologies* - Instructions for contributors**

## **How to submit to *Wearable Technologies***

All new submissions should be submitted online [here](#).

If you are visiting the online submission site for the first time, you must create a new account by clicking on 'register here'. Once logged in, authors should click on the Corresponding Author Centre, from which point a new manuscript can be submitted, with step-by-step instructions provided. Once your submission is completed you will receive an email confirmation.

## **ORCID IDs**

*Wearable Technologies* requires that all corresponding authors identify themselves using ORCID when submitting a manuscript to the journal. Joining ORCID is fast, free and you do not need to have a current affiliation. ORCID provides a unique identifier for researchers and, through integration in key research workflows such as publication and grant applications, provides the following benefits:

- Discoverability: ORCID increases the discoverability of your publications, by enabling smarter publisher systems and by helping readers to reliably find work that you've authored.
- Convenience: As more organisations use ORCID, providing your ID or using it to register for services will automatically link activities to your ORCID profile, and will save you re-keying information multiple times.
- Keeping track: Your ORCID profile is a neat place to record and display (if you choose) validated information about your research activities.

If you don't already have an ID, you'll need to create one if you decide to submit a manuscript to *Wearable Technologies*. You can register for one directly from your user account on ScholarOne or via <https://orcid.org/register>. If you already have an ID, please use this when submitting by linking it to your ScholarOne user account. Simply log in to your account using your normal username and password. Edit your account by clicking on your name at the top right of the screen and from the dropdown menu, select 'E-Mail / Name'. Follow the instructions at the top of the screen to update your account.

## Rules of Submission

*Wearable Technologies* considers all manuscripts on the strict condition that:

1. The manuscript is your own original work, and does not duplicate any other previously published work;
2. The manuscript has been submitted only to the journal - it is not under consideration, accepted for publication or in press elsewhere. Manuscripts may be deposited on pre-print servers;
3. All listed authors know of and agree to the manuscript being submitted to the journal; and
4. The manuscript contains nothing that is abusive, defamatory, fraudulent, illegal, libellous, or obscene.

The journal adheres to the [Committee on Publication Ethics \(COPE\) guidelines](#) on research and publications ethics. All submissions to *Wearable Technologies* will be checked by iThenticate, a plagiarism detection tool. Text taken directly or closely paraphrased from earlier published work that has not been acknowledged or referenced will be considered plagiarism. Submitted manuscripts in which such text is identified will be withdrawn from the editorial process.

## Peer review process

Submitted manuscripts are first sent to the Editor-in-Chief who may render an immediate ‘reject without review’ decision should the manuscript be deemed unsuitable or inappropriate. Approved manuscripts will be assigned to an Associate Editor who will oversee the single-blind peer review process. The manuscript will be sent to at least two reviewers for comment. Authors can check the status of their submission in review by logging on to the online submission system. After an editorial decision is made, an email containing the comments from the reviewers and the editor will be sent to the author. The decision email is also accessible at the Author Center of the online system.

## Types of article

*Wearable Technologies* publishes the following article types:

- Research articles: Regular submissions to *Wearable Technologies* are termed ‘research articles’ and must contain original research.
- Review articles: Articles reviewing the developments and achievements within areas of interest to the wearable technology community are welcomed as ‘reviews’.
- Editorials: generally from the Associate Editors, and occasionally solicited from Guest Editors

## Manuscript Preparation

All articles must be written in English and authors are encouraged to compose their articles in LaTeX or Word

Articles should be written in a concise manner; though there is no strict page limit, each article will be judged on its own merits, and those deemed excessive in length will be rejected or will require significant revision.

S.I. units should be used throughout in text, figures and tables. Authors should spell out in full any abbreviations used in their manuscripts. Citations to references should be given in the APA style.

Where material is reprinted or adapted from a previously published work, authors are responsible for obtaining written permission from the copyright owners of the previously published work.

## Manuscript format

### Title

The Title should be informative, specific and be an attractor to the content of the article.

### Abstract

Each article should contain an abstract of not more than 250 words. The Abstract should tell the reader about the content of the article and should be standalone text without any references, to allow it to be listed independently of the article. The Abstract is not the place for the argument, explanation or editorializing. The Abstract should be added to the online submission system in the freetext box provided. The Abstract should also be included in the main PDF of the submitted article.

### Keywords

Authors should not enter keywords on the manuscript, as these must be chosen by the author during the online submission process and will then be added during the production process.

### Figures

For guidance on producing figures, please visit the [Cambridge Journals Artwork Guide](#). Figures should be referred to consecutively as Fig. 1 etc.

### Tables

Tables should be headed by a self-explanatory title and referred to consecutively as Table 1 etc.

### References

References and citations should be formatted correctly in journal style when the article is submitted to the journal but formatting is not grounds for rejection at the submitting phase.

References in text should follow the APA citation style. Find here [Endnote style](#) and find here [Zotero style](#) by searching APA 6th edition.

### Footnotes

Footnotes should be numbered using roman numerals.

### Acknowledgements

You may acknowledge individuals or organisations that provided advice, support (non-financial). Formal financial support and funding should be listed in the Financial Support section (see below).

## Required Statements

These statements should be included at the end of the manuscript, before the References section.

### Author Contributions

A short statement should be provided indicating how each author contributed to the work. For example: AB and CD conceived and designed the study. CD and EF conducted data gathering. GH performed statistical analyses. AB, EF and GH wrote the article.

### Financial Support

Please provide details of the sources of financial support for all authors, including grant numbers.

*EXAMPLE:* "This work was supported by the National Science Foundation (grant number XXXXXXXX)".

Multiple grant numbers should be separated by a comma and space, and where research was funded by more than one agency the different agencies should be separated by a semi-colon, with 'and' before the final funder. Grants held by different authors should be identified as belonging to individual authors by the authors' initials.

*EXAMPLE:* "This work was supported by the Deutsche Forschungsgemeinschaft (A.B., grant numbers XXXX, YYYY), (C.D., grant number ZZZZ); the Natural Environment Research Council (E.F., grant number FFFF); and the Australian Research Council (A.B., grant number GGGG), (E.F., grant number HHHH)".

Where no specific funding has been provided for research, please provide the following statement:

"This research received no specific grant from any funding agency, commercial or not-for-profit sectors."

### Conflicts of Interest declarations

Please provide details of all known financial, professional and personal relationships with the potential to bias the work. Where no known conflicts of interest exist, please include the following statement: "None."

### Data Availability Statement

Articles should contain sufficient information to allow others to understand, verify and replicate new findings. Therefore we encourage authors to include a Data Availability Statement in their manuscript. This statement should include information on where resources such as data, materials, protocols and software code can be accessed. If data sharing is not applicable, authors should state that 'Data sharing is not applicable to this article as no new data were created or analysed in this study.'

### Ethical Standards (only if applicable)

All Cambridge journals adhere to a set of Ethical Standards, as laid out [here](#).

Where research involves human and/or animal experimentation, the following statements should be included:

"The authors assert that all procedures contributing to this work comply with the ethical standards of the relevant national and institutional committees on human experimentation and with the Helsinki Declaration of 1975, as revised in 2008." and "The authors assert that all procedures contributing to this work comply with the ethical standards of the relevant national and institutional guides on the care and use of laboratory animals."

## **Supplementary Material**

Additional material (e.g. data sets, large tables) relevant to the article can be submitted with your manuscript for publication online, where they are made available via a link from the article. The article should stand alone without these data. Supplementary Material must be cited in a relevant place in the text of the article.

Please note that (unlike figures included in the printed article) captions or legends should be included for all figures and tables in Supplementary Material. You should number figures or tables with the prefix 'S', e.g. Supplementary Figure S1, Supplementary Table S1.

Supplementary Material is not checked, copyedited or typeset after acceptance and it is loaded onto the journal's website exactly as supplied. You should check your Supplementary Material carefully to ensure that it adheres to journal styles. Corrections cannot be made to the Supplementary Material after acceptance of the manuscript. Please bear this in mind when deciding what content to include as Supplementary Material.

## **Author Language Services**

Cambridge recommends that authors have their manuscripts checked by an English language native speaker before submission; this will ensure that submissions are judged at peer review exclusively on academic merit. We list a [number of third-party services](#) specialising in language editing and/or translation, and suggest that authors contact as appropriate. Use of any of these services is voluntary, and at the author's own expense.
