



CALL FOR MANUSCRIPTS

Themed Issue on Well-Being in Clinical and Translational Science

We are issuing a Call for Papers for a special themed issue of the *Journal of Clinical and Translational Science (JCTS)* that will focus on evidence-based practices and interventions to support well-being and retention in the CTS workforce.

The unprecedented circumstances associated with the COVID-19 pandemic and high rates of burnout in the translational workforce have highlighted the need for a comprehensive approach to well-being across training stages and job roles. The themed issue seeks to provide a venue for identifying and improving health and well-being concerns across different stages of the translational science workforce and disseminating effective interventions. We are particularly interested in papers focused on evidence-based practices and assessment of well-being initiatives and implementation of evidence-informed policies and practices.

We are inviting a wide range of papers addressing well-being across the CTS spectrum, including but not limited to

- Built environment (e.g. influence of design and architecture)
- Education (e.g. students and faculty, translational education)
- Occupational health (i.e. health workforce)
- Persons with disabilities (e.g. vision impairment, autism spectrum disorder, physical disability, invisible disabilities)
- Public health
- Under-represented and underserved populations (e.g. deaf/hard of hearing or language minority communities, immigrant/refugee health, racial/ethnic well-being equity, sexual and gender minority well-being, gender-related differences in well-being, rural populations; poor and under-resourced populations)

Submissions should be made online via the Journal's ScholarOne submission site (<https://mc.manuscriptcentral.com/jcts>) no later than **April 1, 2023** Authors are asked to select "Well-Being" in the Themed Issue submission question when submitting to this issue.
