



Based on a comparative study of 15 Western European countries, this edited volume examines the responses of long-term care homes for older people to the COVID-19 pandemic.

It analyses the preparedness of governments and residences and the structural weaknesses revealed and exacerbated by the crisis, such as staff shortages, the precariousness of employment in the sector, and the deficient coordination between the health and caring sectors.

By examining the governance structures of the care home sector and their performance before and during the crisis, the book highlights the institutional, organisational, and management challenges facing care homes, both in continuing to provide services to an increasingly ageing population and in the event of future public health crises.


As populations age around the world, there is an urgent need to address the inadequate and unequal provision of care and support to older and disabled people.



From March 2020, the COVID-19 pandemic changed daily life in Britain dramatically with the introduction of unprecedented restrictions and lockdowns. To understand how people reacted, this book draws on the diaries of 68 men and women aged 70 and above, capturing their thoughts and experiences over the following months. Although these older diarists considered themselves among the more fortunate at the time, their entries reveal both highs and lows. There were anxieties and frustrations but also much positivity and, often, a reluctance for an over-hasty return to pre-pandemic times.

Through these personal and contemporaneous accounts, the book offers a unique contribution to our understanding of the pandemic and its significance in modern social history.


The symptoms of menopause transitions have profound implications for work and are, in turn, affected by work. Despite this, the topic is rarely discussed in management and organisation studies.

Offering theoretical frameworks from experts as well as possible practical

approaches that can be implemented in workplaces to support women transitioning through menopause, this is a useful reference for academics and policy makers working in the field.



Ageing in Place in Urban Environments considers together two major trends influencing economic and social life: population ageing on the one side and urbanisation on the other. Both have been identified as dominant demographic trends of the twenty-first century. Cities are where the majority of people of all ages now live and where they will spend their old age. Nevertheless, cities are typically imagined and structured with a younger, working-age population in mind while older people are rarely incorporated into the mainstream of thinking and planning around urban environments. Cities can contribute to

vulnerability arising from high levels of population turnover, environmental problems, gentrification, and reduced availability of affordable housing. However, they can also provide innovative forms of support and services essential to promoting the quality of life of older people. Policies in Europe have emphasised the role of the local environment in promoting "ageing in place", a term used to describe the goal of helping people to remain in their own homes and communities for as long as they wish. However, while this has been the dominant approach, the places in which older people are ageing have often proved to be challenging environments. The book explores the forces behind these developments and how older people have responded.



There are two prevailing myths about Japanese society: first, that it has a successful elderly welfare system and second, that it has a successful criminal justice system. Both of these myths reinforce a social imaginary where cultural values of family and community harmony make extensive state intervention unnecessary. Yet not only are both of these myths and their arguments deeply flawed, but they also obscure the more troubling reality that institutions of welfare and punishment in Japan are coextensive, both keeping Japan's growing population of "excess" older people contained and controlled rather than providing ways for them to

integrate and flourish.

Elderly ex-offenders are some of the most vulnerable and marginalised groups in Japan today, with high levels of poverty and homelessness, disability, mental health problems, and social isolation. Those with a history of incarceration and, by extension, their families, face stigma and discrimination that further erodes their ability to reintegrate and puts them at greater risk of reoffending. Unlike other countries, older people in Japan have a higher rate of reoffending than other age groups. In *Unsettled Futures*, author Jason Danely argues that we cannot dismiss these individuals merely as deviants. Rather, their circumstances reveal deep contradictions in the overlapping terrain of welfare and punishment, and the precarity that forecloses on possibilities for older people to build a good life.



This book offers a new critical framework for understanding the processes of politicising and gendering care for older people and their manifestations in several European contexts. It interrogates how care for older adults varies across time and place while searching for an in-depth comprehension of how it becomes an arena of political struggle and the object of public policy in different countries and at various societal and political levels. It brings together multidisciplinary contributions that examine the issue of care for older people as a political concern from

many angles, such as problematising care needs, long-term care policies, home care services, institutional services and family care. The contributions reveal the diversity of situations in which the processes of politicising and gendering care for older adults overlap, contradict or reinforce each other while leading to increased gender (in)equalities on different levels.





Populations are ageing in a public health climate where brittle public services are struggling to cope with the demands associated with ageing populations. LGBTQ+ populations also continue to grow in line with these trends but receive much less attention in the scholarly debate. This short work offers a theoretical and practical exploration of LGBTQ+ ageing in the UK, drawing on a blend of public health and occupational therapy theory, and phenomenology.

Based on original primary evidence gathered through a survey and interviews, Fox and Hannis stimulate a new and much-needed discourse in the literature about hidden populations during the World Health Organisation's Decade of Healthy Ageing. Advancing the discourse on ageing by applying multiple theoretical bases to explain how minority ageing populations interact with, and are shaped by, their environments over the life course, Fox and Hannis explore how specific social determinants over the life course impact the health outcomes and engagement with healthy ageing practices of older LGBTQ+ populations.

In navigating the intersection of queer history, public health, and ageing, *LGBTQ+ Healthy Ageing* serves as a vital resource for scholars, practitioners, and anyone committed to promoting healthy ageing for all.



In this book, Per H. Jensen provides a theoretical and empirical analysis of retirement practices in Denmark, Germany and the UK, in order to interrogate the factors behind rapidly increasing retirement ages.

Drawing on the age arrangement approach, *Rapidly Increasing Retirement Ages* considers the position of older workers in the context of changing norms and ideals, discourses, welfare states, labour markets, and families as well as the changing characteristics of older workers themselves. Jensen uses statistical data to highlight how the developing practices of older workers are prompted by societal transitions including transitions

from early to late exit discourses, from welfare states to enabling states, from closed to open labour markets, from male breadwinner to dual breadwinner family models, and from low to high levels of work ability among older workers. Additionally, Jensen shows how the different dimensions of change are connected and interrelated.







Additionally, the book proposes a professional practice that not only avoids ageism, but also actively contributes to developing anti-ageist frameworks. Building on key earlier work and the authors' experience in

care, ageing and bereavement, it provides a detailed overview of the processes and sociology of ageing and how these are affected by cultural differences. Successfully blending theory and practice, individual chapters examine various physical, psychological, and social problems encountered when working with older people that can serve as a barrier to dignity, as well as how care duties can be carried out to ensure the respect of the ageing individual when managing issues such as dementia and grief.



It demonstrates how boundaries between paid and unpaid work are flexible, varying considerably with conditions, time, place and intersectional populations. By examining the complex labour process

within nursing homes, this book provides insight and understanding which will be critical in planning for nursing home care post-pandemic.



Given growing caseloads, limited funding and staff shortages, the need for coordination in healthcare and elderly care is at an all-time high. This timely book conducts a cross-national analysis of coordination problems in healthcare and long-term care systems and provides novel insights on how to improve the lives of the elderly.

This book focuses on four European welfare states with well-developed healthcare and long-term care systems: Germany, the Netherlands, Sweden, and Switzerland. It examines the two critical interfaces of the

transition from hospital care to home care and integrated home care arrangements. Using empirical data and extensive interviews with major stakeholder organisations, the authors identify best practice examples of healthcare and long-term coordination. The book ultimately considers both professional-level and system-level coordination problems, suggesting original solutions in financing reform, institutionalisation, and academisation.


As the average life expectancy continues to rise, the long-held assumption that age is a protective factor against criminal offending and victimisation is being challenged. Recognising that people who commit offences later in life are an overlooked group in criminology, *Not Your Usual Suspect* is the first collection to assemble research on different forms of violence and abuse perpetrated by individuals predominantly over 60.

Examining intersections of gender, crime and age, this collection highlights how the increase in older people entering the criminal justice system has emphasised the unpreparedness of policies and practices for dealing with

this cohort. Moving beyond existing research and policy which has focused primarily on those who are sentenced in later life for crimes they committed as younger adults – so called historic crimes – the chapters pay crucial attention to those who commit offences as long-term, repeat or first-time offenders in later life.

Offering an important contribution for researchers across the criminological, gerontological, feminist and elder abuse fields, *Not Your Usual Suspect* expands existing research to consider the behaviour and drivers of older offenders, addressing the increasingly important issue of how the needs of this group can be addressed by policy and practice.



looks afresh at what makes home-based care possible or impossible and how these considerations can help establish a deeper understanding necessary for good policy and practice.



the Aging Face and Body delineates how ageing affects emotion communication and person perception by bringing together research across multiple disciplines.



It provides critical analysis of key policies and professional practice over three decades and highlights the continuing challenges faced by people in caring relationships, as well as reflecting on developments in the position of unpaid carers in the system of social care. By questioning why this crucially important sphere of human life

remains under-resourced, it sheds light on the ways in which care is understood and how policy makers and service providers perceive the need for support.

Building on concepts of adult human development and empowerment, Elizabeth Brooke reframes 'active ageing' to include forms of creative expression and cultural participation crucial to transforming later stages of the life course.

Focusing on the micro-level of the experiences of older adults in visual arts, dance, theatre and music, the book showcases multi-perspective case studies compiled from community-based initiatives and care settings

in the United States, United Kingdom, Ireland, and Australia to explain creative ageing in practice. Through the analysis of arts forms embedded in theoretical sociological frameworks and the lens of cultural gerontology, the case studies explore and develop theoretical insights about older adults' experiences of artmaking which also contest ageism. The case studies interrelate meso-level interactional processes entailed in art-making and macro-level structural contexts. Drawing out success factors, the author articulates a transferable policy framework and practical recommendations for a multi-level model of creative ageing.


Many developed nations face the challenge of accommodating a growing, ageing population and creating appropriate forms of housing suitable for older people.




Following the development of anti-retroviral therapies (ARVs), many people affected by HIV in the 1980s and 1990s have now been living with the condition for decades.


Recognising a rapidly ageing population is one key concern faced by cities, as regards the challenge it would present to healthcare system. This book looks at ageing in China's population as well as the delivery and financing of long-term care (LTC) in China.



The book compares key features of long-term care insurance (LTCI) schemes in 15 pilot cities and evaluates the sustainability of various financing models adopted by the cities in the LTCI schemes. The book uses an interpretive case study approach to give an in-depth look into the LTC models in three pilot cities — Qingdao, Nantong, and Shanghai. The

three cities represent three different models of financing and delivering LTC. To assess how effective the LTC models in these three cities are, the book uses five criteria, including utilisation of medical resources, cost, equity, quality of care and sustainability. Also, the authors discuss how the financing and delivery of LTC can be improved in China, the impact of the 2019 coronavirus (COVID-19) pandemic on older adults in need of LTC in the country and the implications of China's LTCI reform for other countries.



This book is the first comprehensive ethnographic study of the diversity of living and ageing experiences of three groups of older migrants – return, lifestyle and ageing-in-place labour migrants – from a comparative perspective. It explores the motivations, ageing experiences and aspirations of transnational ageing migrants in the context of the Portuguese islands of the Azores and situates the research within debates of the ageing-migration nexus. The book's interdisciplinary approach to transnational embodied and emplaced experiences of ageing facilitates a dialogue between various fields concerned with

ageing and mobilities, including geography, anthropology, sociology, social gerontology, social work, and studies of health and wellbeing.

Yamagishi, Takakazu

Japan is the fastest ageing country, with the largest super-aged society in the world and growing larger by the day, yet its universal health care costs are relatively low. In *Health Insurance Politics in Japan*, Takakazu Yamagishi draws back the curtain for an international audience and investigates how Japan has been able to control health care costs through health insurance politics.

Covering the period from the Meiji Restoration to the Abe Administration, Yamagishi uses a historical institutionalist approach to

examine the driving force behind the development of health insurance policies in Japan. Yamagishi pays special attention to the roles of government and medical professionals, the main actors of the policymaking and medical worlds, in this development.
