## NOTES ON THE CONTRIBUTORS

**ALEJANDRO PORTES**, John Dewey Professor of Sociology and Chair at The Johns Hopkins University, has written some two hundred articles and chapters on urbanization, international migration, development, and the informal economy. His most recent books are Immigrant America: A Portrait and City on the Edge: The Transformation of Miami, the latter coauthored with Alex Stepick.

**JOSE ITZIGSOHN** is a doctoral student in sociology at The Johns Hopkins University. His dissertation will analyze comparatively the informal economies in the metropolitan areas of Santo Domingo and San José, Costa Rica.

**CARLOS DORE-CABRAL**, a doctoral student in sociology at Johns Hopkins, is a sociology professor at the Universidad Nacional de Santo Domingo. He is the author of Reforma agraria y luchas sociales en la República Dominicana.

HARLEY SHAIKEN. a professor in Social and Cultural Studies at the Graduate School of Education at the University of California, Berkeley, specializes in issues of work, technology, and global production. He is also affiliated at Berkeley with the Institute of Industrial Relations and the Center for Latin American Studies as well as with the Center for U.S.-Mexican Studies at the University of California, San Diego.

**BRADFORD L. BARHAM** is Assistant Professor of Agricultural Economics at the University of Wisconsin. His current research examines the impact of trade liberalization on the structure and performance of agriculture in Mexico, Central America, and the United States.

**OLIVER T. COOMES**, Assistant Professor of Geography at McGill University in Montreal, recently completed his doctorate at the University of Wisconsin– Madison. He is currently pursuing his research interests in historical and contemporary economic livelihood practices of Amazonian peasants, adaptive responses of traditional peoples to environmental change, and rural economic development and environmental conservation in Latin America.

**ANDREW MORRISON** holds appointments in economics at Tulane University and the University of New Mexico. His areas of research include migration, urbanization, and labor markets in Latin America.

**RACHEL MAY** is an assistant professor in liberal studies at the University of Washington, Tacoma. Her research interests include Central American popular movements and political violence.

**w. GEORGE LOVELL** is Professor of Geography at Queen's University in Kingston, Ontario. He wrote Conquest and Survival in Colonial Guatemala: A Historical Geography of the Cuchumatán Highlands, 1500–1821 and coedited with Noble David Cook "Secret Judgments of God": Old World Disease in Colonial Spanish America.

**ENRIQUE MAYER** is Professor of Anthropology at the University of Illinois at Urbana-Champaign. From 1985 to 1993, he directed the Center for Latin American and Caribbean Studies. His research focuses on agrarian issues of Andean society from ecological, economic, and social perspectives.

**ROBERT L. SIMS** is Professor of Foreign Languages at Virginia Commonwealth University in Richmond. A specialist in modern French and Latin American literature, his most recent publication is The First García Márquez: A Study of His Journalism from 1948 to 1955.

Bolivia and Peru are the main areas of research for DAVID L. BROWMAN. His prehistoric interests include the origins of domestication and the functioning of the Tiwanaku confederation, while his ethnohistoric and ethnographic interests center on markets and llama caravan trade as well as camelid contributions to various economic institutions over time.

JOHN FREDERICK SCHWALLER directs the Academy of American Franciscan History in Berkeley, California. The author of several books on the Catholic Church in sixteenth-century Mexico, he is studying Nahuatl, the "Aztec language." He is also writing a biography of don Luis de Velasco the younger, viceroy of Mexico and Peru and president of the Consejo de Indias.

**BARBARA WEINSTEIN** is Associate Professor of History at the State University of New York at Stony Brook. The author of The Amazon Rubber Boom, 1850–1920, she is currently completing a study of industrialists and strategies for labor control in São Paulo from 1920 to 1970.
